REQUESTING ORGANIZATION: The Indianapolis Legal Aid Society (Indy Legal Aid) is celebrating its 82nd year in 2023! Indy Legal Aid is a 501(c)(3) non-profit organization, Federal ID #35-1045153, and was founded in 1941 by The Indianapolis Foundation, the law school (now Indiana University Robert H. McKinney School of Law), the Indianapolis Bar Association, and the United Way (formerly the Community Chest). The Indianapolis Legal Aid Society is one of a handful of grassroots legal aid organizations left in the United States.

SERVICES PROVIDED: Indy Legal Aid is a full-service law firm for low-income individuals and families. It delivers hope to Central Indiana's most vulnerable citizens when they have nowhere else to turn. With a long-standing tradition of efficient, direct, and immediate service, Indy Legal Aid is the only public service law firm in Indiana where individuals can meet with an attorney within three days of scheduling a consultation. Indy Legal Aid charges no attorney fees for those who qualify and treats its clients with the same dignity and respect afforded clients of a private law firm. Indy Legal Aid attorneys interview, fully counsel, and represent approximately 5,000 clients every year. Issues addressed include guardianship, custody and child support, housing, driver's license reinstatement, and a variety of other issues.

MISSION: The Indianapolis Legal Aid Society is dedicated to ensuring qualified low-income persons in the Central Indiana community have immediate and direct access to quality legal assistance for civil disputes.
